INTRODUCTION

Today, there are over one million SMEs employing seven million workers in Malaysia, making it increasingly difficult for the authorities to monitor the Occupational Safety and Health (OSH) requirements for each premise. This is necessary to ensure safety and health at the workplace.

Perhaps in relation to that, the number of fatality cases from SMEs due to occupational accidents is also rising.

Due to this, the Department of Occupational Safety and Health, under the Ministry of Human Resource has come up with the OSH Coordinator initiative. An OSH Coordinator will be the representative safety practitioner to self-regulate the safety and health provision of their premises.

In addition, this role is included in the Occupational Safety and Health (Amendment) Act 2022 in Section 29A, gazetted earlier this year requiring all employers that have "5 or more employees" to appoint an OSH Coordinator.

ABOUT THE COURSE

This 3-day OSH Coordinator Training Program is designed to equip participants with a comprehensive knowledge of occupational safety and health and how to adopt OSH practices at the workplace on a daily basis.
